## General Information

The Federal Reserve System’s Reporting Central Application provides the ability for a reporting entity to submit their reports electronically through the use of an XML file. This document describes the required format for creating the XML file for the FR 2590 (Single-Counterparty Credit Limits Reporting Form) report.

## How the XML File Is Structured

Each XML file contains financial data for one reporting entity and as of date. The data in the file is organized into the following sections.

- Reporting File
  - Create date
  - Create time
- Report
  - Respondent Id
  - As Of Date
  - Series Id
- Item Data
  - Value
